

Reopening of pools, bars, restaurants, cinemas, museums and public transportation in Mexico City

Mexico City, August 11, 2020

On August 9, 2020, the Official Gazette of Mexico City (the "CDMX") published the fifteenth notice, announcing the color of the CDMX Epidemiological Stop Light and the resumption of activities corresponding to such (the "Notice").

The Notice states that during the period, which takes place between August 10 and 16, 2020, the Epidemiological Stop Light will remain **orange**, and the following activities shall resume:

- On August 10th, activities will resume in pools with capacity according to the size of the pool to ensure a healthy distance (one person per lane). Pools shall have to comply with different health measures such as: not sharing equipment, carrying out the signaling of flows outside the pool and complying with the guidelines on health protection measures (the "Guidelines") applicable to the sports clubs and outdoor sports activities sector.
- As an extraordinary measure, as of August 10th, 2020, commercial establishments whose line of business is a party hall or mainly the sale and/or distribution of alcoholic beverages in open containers and/or by cup, for indoor consumption (bars, canteens or clubs), must comply with the temporary program for reopening bars and restaurants ("REABRE" for its acronym in Spanish), through which the necessary health measures to resume activities will be established, provided that the traffic light remains **orange**. In this case, establishments must give notice through the platform <http://covid19.cdmx.gob.mx/medidassanitarias> and comply with a series of requirements.
- On August 11th, 2020, activities will resume in museums, with a capacity of 30%, and transport for tourist use in the CDMX, with a capacity of 40% from 9:00 to 19:00. These activities must comply with different health measures established in the Agreement and the corresponding Guidelines.
- On August 12th, 2020, activities will resume in cinemas, with a capacity of 30% in screening rooms and candy, food and beverage areas. Among the sanitary measures that must be observed in cinemas, are the following: mandatory use of face masks, the schedule of the last show will be at 20:00 pm, avoiding large groups, respecting the healthy distance regulations, placing antibacterial gel dispensers with 70% of alcohol in common areas, complying with the Guidelines to be met by the Cinema Industry to resume activities towards a safe return to the New Normal in the CDMX, among others.
